

## An unusual campaign season, start to finish

A majority of U.S. voters set aside all evidence of Republican nominee Donald Trump's mental decline, adoration of dictators, criminal convictions, and hostility to the U.S. Constitution and gave him a decisive victory November 5 over Democratic presidential nominee Kamala Harris.

Mother Jones magazine called the 2024 presidential election the "most anti-LGBTQ election in decades." And, on Wednesday morning, many post-election political analysts were crediting much of Trump's victory to the campaign's \$21 million investment in an anti-transgender ad. The ad ran more than 30,000 times — especially during televised football

### Hope and Help for Queer Families After the Election

The election of Donald Trump to a second term as president feels like a body blow. The danger of his policies to LGBTQ and other marginalized people is real. Nevertheless, there are actions LGBTQ parents can take now to protect and support our families—and there are a few things that are giving me hope.

One thing LGBTQ parents should do immediately is make sure to have secure legal protections in place. This is especially important for nongestational and nongenetic parents, whose legal relationships with their children may still be called into question, even if they are married and on their children's birth certificates. Because of bias and discrimination, both married and unmarried LGBTQ parents are advised by LGBTQ legal experts to have the security of a court judgment, not just a birth certificate, to protect their child-parent relationships no matter where they may move or travel. Wills, powers of attorney, and healthcare proxies are also critical to protect LGBTQ families more broadly. For all of the above, it is important to get advice from someone well versed in LGBTQ family law in your specific state. If you need legal assistance, the National LGBTQ+ Bar Association maintains a Family Law Attorney Directory of experienced LGBTQ family law practitioners. Additionally, several major LGBTQ legal organizations, including GLAD Law, Lambda Legal, the National Center for Lesbian Rights, and the Transgender Law Center offer helplines that can address questions, provide attorney referrals, and

## Rep. Moulton Faces Backlash Over Transgender Sports Comments

Massachusetts Congressman Seth Moulton has defended controversial remarks about transgender athletes, sparking criticism from LGBTQ+ advocates and fellow Democrats.

In a recent interview with The New York Times, Rep. Moulton, who represents Massachusetts' 6th congressional district, criticized what he views as the Democratic Party's approach to identity politics.

"Democrats spend way too much time trying not to offend anyone rather than being brutally honest about the challenges many Americans face," Moulton said. "I have two little girls, I don't want them getting

run over on a playing field by a male or formerly male athlete, but as a Democrat I'm supposed to be afraid to say that."

The congressman's comments prompted swift reaction from local officials and advocacy groups. Salem City Councilor Kyle Davis called for Moulton's resignation in several social media posts. Massachusetts State Democratic Rep. John Moran, who is gay, described Moulton as "weak" in a post on X. The same week, Matt Chilliak resigned, though the reason for his departure remains unclear.

MassEquality challenged Moulton's terminology in a state-

## 25th Annual Transgender Day of Remembrance to Honor Rita Hester and Transgender Community

BOSTON – The 25th annual Transgender Day of Remembrance (TDOR) will be commemorated with three days of events and community gatherings from November 15–17, 2024. While TDOR is officially observed on Wednesday, November 20, Boston's city-wide events will begin the weekend prior to honor the lives

of transgender people lost to violence and to support those who continue to face threats of discrimination and harm.

TDOR was established following the unsolved 1998 murder of Rita Hester, a Black transgender woman in Allston, Massachusetts. Over two decades later, Rita's tragic story re-

mains a poignant reminder of the ongoing struggles for justice, particularly for transgender people of color. This year's events, organized by a coalition of transgender-led advocates and community groups, continue to highlight the urgency of addressing the disproportionate violence and discrimination faced by the transgender

community.

"We strive to create spaces for connection and healing, recognizing the emotional and physical toll that rising anti-trans violence and political hostility have on our community," said Chastity Bowick, TDOR planning

games—and apparently helped win over young men of all races. In a campaign heavily divided by gender—including the possibility that the U.S. would elect its first woman president—the ad apparently helped secure the popular vote and the necessary electoral votes in closely contested swing states.

And much of the post-game commentary criticized the Harris campaign's failure to produce any response to the ad.

Fox News reporter Bret Baier tried to get some traction for the anti-LGBTQ tactic during his interview with Harris October 16.

"Are you still in support of using taxpayer dollars to help prison inmates or detained illegal aliens to transition to another gender?" asked Baier.

"I will follow the law, and it's a law that Donald Trump actually followed," noted Harris. The ads and various speeches by Trump at rallies, derided the "transgender insanity" in schools. Trump repeatedly characterized Harris' position as supporting the use of taxpayer funding for "sex-change operations" and transgender people in girls and women's sports.

The ad did not, of course, explain that a 1976 U.S. Supreme Court ruling held that the Eighth Amendment requires federal prisons to make "medically necessary" treatment available to prisoners. The American Medical Association and others have deemed "mental health care, hormone therapy, and gender-affirming surgical procedures [as] medically necessary..."

The Trump ads used a video clip showing a transgender basketball player towering over her young female teammates. (There is no way of telling whether the images were authentic or fabricated by artificial intelligence.) Another showed Harris responding in 2019 to a question from a transgender interviewer, asking her position on the availability of treatment for gender dysphoria for prisoners. In response, Harris chose her words carefully, noting that the law requires every transgender person in prison "have access" to medically necessary treatment.

But however much the anti-trans ads may have gamered Trump a margin of victory, at deadline, data available from major media outlets showed Trump with 71 million votes to Harris' 66 million. News media tallies also indicated Trump won at least four and possibly all seven swing states, finishing the race with 277 electoral votes to Harris' 224. (It takes 270 to win.)

The LGBTQ community invested heavily in the Harris bid to succeed Democratic President Joe Biden and become the first woman and first woman of color to win the presidency. LGBTQ papers, including those in the three swing states Harris had to win (Wisconsin, Michigan, and Pennsylvania), endorsed Harris. LGBTQ groups did, too, including the Human Rights Campaign, the National LGBTQ Task Force Action Fund, the National Center for Transgender Equality Action Fund, and the Equality Political Action Committee.

Log Cabin Republicans backed Trump and used the transgender issue itself.

"Harris and [Democratic Vice-Presidential nominee Tim Walz] are crusaders for a small

but powerful cabal of the LGBT Left which wants to erase the concept of biological sex from society, expose young children to overtly sexualized and ideological content, and strip parents of their rights to make critical decisions about their children," wrote national Log Cabin President Charles Moran, in an op-ed September 13 in Newsweek magazine.

 The 81-year-old President Biden withdrew his bid for re-election in July, after showing signs of cognitive difficulty and confusion during a debate with Trump. Biden immediately threw his support behind his vice president, Harris, creating a groundswell of support for the 60-year-old former San Francisco prosecutor and California attorney general. Biden's support, coupled with the party's obvious relief that it was overcoming concerns about its nominee's ability to serve, seemed to cure Democrats' panic. But race and gender started to play a major part in voters' thinking.

Voters in seven highly contested swing states gave Trump control of the White House and gave Republicans a decisive majority in the U.S. Senate. At deadline, partisan control of the U.S. House had not yet been determined, but the New York Times reported that Republicans were leading with 197 seats to Democrats 177. At deadline, there were still 64 seats yet to be decided, many of them in California. That leaves open the hope that Democrats might be able to take majority control of the U.S. House. If they don't, Trump will have a rubber stamp Congress with Republican majorities in both chambers.

Joe Scarborough, host of the popular MSNBC commentary show Morning Joe, said Wednesday morning he believes the anti-transgender ads that popped up during football games in the swing states "had a bigger impact than any ad that ran and that's why they ran it 30,000 times."

Washington Post commentator Matt Bai said, "Democrats dug themselves into a hole on cultural issues and identity politics."

One of the ads' closing lines was "She's for they/them, he's for you," noted Bai, who agreed that "Trump's vicious transgender ad in the closing weeks was probably the most effective of the cycle."

"I think that probably landed with a lot of traditionally Democratic voters who feel like the party is consumed with cultural issues while the economic issues don't really change," wrote Bai.

On a podcast of conservative Joe Rogan, Republican vice presidential candidate J. D. Vance said, "Frankly, I wouldn't be surprised if me and Trump won just the normal gay guy vote because they just want to be left the hell alone." (Reporter's note: Readers should consider listening to Vance's intonations to judge for themselves what he means to say.) Openly gay CNN news anchor Anderson Cooper pondered Vance's comment on his show.

"I'm curious where the line is between a 'normal gay person' and a not normal gay person is," said Cooper. "I'm assuming that wearing as much make-up as Donald Trump wears—that would be considered not normal—fine for Donald Trump but on a gay guy that wouldn't be considered normal."

Los Angeles Times reporter Noah Bierman told ABC that, while transgender people are not a top issue for Republicans in the same way migrants are, the ads are "really intended to bring the culture wars back in."

"The Trump campaign is heavily focused on young men, and they feel like this is an issue

that resonates with them," said Bierman. He said they are also intended to paint Harris as an out of touch liberal.

A national poll of 806 registered voters, conducted online and by phone in mid-October, found that eight percent (64 voters) identified themselves as LGBTQ+. While voters overall split 50 percent for Harris, 47 percent for Trump, three percent others, voters who identified themselves as LGBTQ+ preferred Harris 78 percent to Trump's 20 percent and other's two

percent. (The poll also provided some interesting data on how "masculine" and how "feminine" the voters perceive each candidate to be and how that affected their votes.)

Coincidentally, three states voted on same-sex marriage laws Tuesday: California, Colorado, and Hawaii. Although the U.S. Supreme Court ruled in 2015 that states had to allow same-sex couples to obtain marriage licenses the same as heterosexual couples, very few states that had banned such marriages took them out of their

state constitutions.

In California, voters approved Proposition 3 to amend the state constitution to repeal Proposition 8, which in 2008 prohibited same-sex marriage. Passed by 61 percent of the vote, Proposition 3 would also amend the state constitution to establish a right of marriage for same-sex couples. The similar measure in Colorado passed Amendment J with 64 percent and, in Hawaii, Question 1 passed with 61 percent.

to slow, stop, and reverse harmful policies – and promote positive ones – and we will continue to support our community with information about your rights and what steps you can take to protect them.

Here are some resources we have compiled. Everyone's situation will be different, and this should not be taken as legal advice. We encourage you to determine what the right steps are for you and to consult with a lawyer when needed.

### Marriage and Relationship Protections

We are prepared to challenge any attempt to reverse the Supreme Court's 2015 marriage equality decision. Additional protections for marriage also exist at the federal level through the Respect for Marriage Act and at the state level in New England and several other states.

However, we know that many people are worried about what could happen in the future, and there are steps you can take to protect your relationship. This includes preparing important legal documents called estate planning documents, in which you designate your spouse, partner if unmarried, or another person to make decisions for you if needed or to be the caregiver for your children and beneficiary of your assets in case of your death. They include:

**Power of Attorney:** a legal document that empowers your spouse (or another person) to make financial decisions in case you are unable to do so.

**Health Care Proxy** (or similar document): a legal document that empowers your spouse (or another person) to make health care decisions in case you are unable to do so. This document may also allow you to authorize your spouse to access your medical information and to visit you in the hospital.

**Will:** a legal document where you describe what you would like to have happen to your children and property in the event of your death.

Typically, these documents are prepared in consultation with an attorney. They can also be prepared to protect unmarried couples.

committee member. "This year, we are especially focused on offering tangible resources and support, while continuing to demand justice for Rita and all trans people lost to violence."

### Family Protections

While marriage and having both parents' names on a birth certificate do offer some protection for families, the most secure option is to have a court decree of parentage. This can be through a co-parent adoption or a court judgment.

New England has many protections for LG-BTQ+ families, including for parents who are not married. There are steps you can take to protect your parent-child relationship, depending on which state you are in and how your family is formed.

### Health Care Access

We understand that the recent election has created real anxiety about potential changes to transgender health care access. While we cannot predict the future with certainty, we are committed to keeping the community informed as situations develop.

First and foremost, we encourage you to discuss any concerns about continuity of care with your current medical provider.

While federal policies could theoretically change in the future, multiple layers of legal and constitutional protections remain in place. Organizations like GLAD Law stand ready to challenge discriminatory laws or unfair federal policy, and LG-BTQ+ and allied advocacy groups will continue working to prevent unfair legislation.

Currently, 26 states have enacted bans on health care for transgender adolescents, and Florida stands alone in having placed restrictions on treatment for transgender adults. The majority of those laws are being challenged in court.

Importantly, 14 states and DC, including Massachusetts, Rhode Island, Connecticut, Maine, and Vermont, have enacted "shield laws" to protect medical providers' ability to continue caring for transgender patients. Two additional states (Arizona and New Jersey) have executive orders protecting care.

In December, the U.S. Supreme Court will hear arguments in a landmark case examining whether states can constitutionally deny transgender adolescents access to established medical care that is routinely provided to others. The federal trial court (in that case and numerous others) struck down such restrictions as violating equal protection principles, finding no legitimate basis for singling out transgender adolescents and denying them standard medical treatments that physicians and major medical organizations have found to be safe and effective. Based on existing constitutional protections against discrimination, we are hopeful about the Court's

ruling. A positive decision in that case should be a bulwark against other efforts to restrict care.

### Schools

We have already seen many attempts at the state and local level to reverse protections for LG-BTQ+ students and censor what students can learn about themselves and others. The incoming administration has indicated a desire to broaden attacks on schools and undermine public education. We can all be prepared to get involved at the local level to protect vital access to education for all students.

Every New England state has protections for LG-BTQ+ students in public schools, and many courts have affirmed that federal Title IX protections apply to LG-BTQ+ students.

We encourage you to inquire about your school's policies, and to visit our state-specific Know Your Rights in School pages for more information and other organizations to reach out to for help.

### Identity Documents and Name Changes

If you want to update your identity documents and/or secure a legal name change, there are resources available to you.

Visit [glad.org/ID](http://glad.org/ID) for self-directed guides for each of the New England states. In many cases, these are changes you can make on your own. However, if you have a more complex situation or need assistance, we also have an ID Project that can pair you with a pro bono attorney. Please note there may be a wait to be matched with an attorney given high demand.

### Other Protections

New England states have a range of important non-discrimination protections that cover employment, housing, health care, and public spaces. Visit our state-specific pages for more information about specific protections and to understand how to work with state non-discrimination commissions if you face discrimination.

This is also a time for all of us to engage with pro-equity state and local leaders to ensure the most robust protections at the state level and to act as a barrier against harmful federal policies.

## In sorrow and hope, fight on MAGA mayhem is not governance

The old adage, "Be careful what you wish for," is about to demonstrate its wisdom.

Millions of people have rewarded a racist demagogue for his provocations by electing him over an accomplished and decent woman of African and South Asian descent. To quote their God Bless The USA Bible, they will reap the whirlwind (Hosea 8:7).

It is time to stop letting people who dominate our politics get away with waving the Bible around while ignoring its wisdom. ment, calling his characterization of transgender girls as "male or formerly male" both "harmful and factually inaccurate." The organization has reached out to Moulton's office to arrange what they hope will be "a productive conversation."

When confronted about the controversy by NBC10 Boston's Matt Prichard on Monday, Moulton stood firm. "What I said is consistent with the view of the majority of Americans, but it's shut out of the democratic party debate,"

Prichard pressed Moulton on his previous sup-

port for LGBTQ+ rights, including his backing of the Equality Act in 2015: "How should constituents square the difference between that Seth Moulton and the remarks we've heard in the last few days?"

"Exactly the same Seth Moulton," the congressman responded. "Why is it not supportive of people you care about to talk about their issues? I don't understand how on earth that's not supportive."

Our last minute "Ask Billy" question comes from James in Baltimore: "What's going on between **KJ Apa** and **Boston Ridge**?"

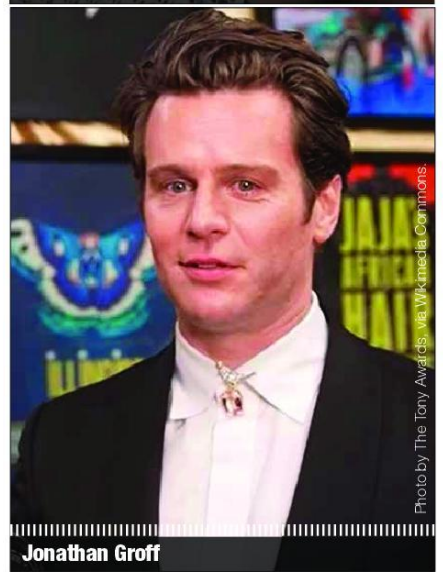

direct you further. You can easily find these resources via a quick online search.

Don't forget that you're not alone. We're facing this as a community. Whether in-person or online, we can support each other and share both our challenges and joys. And every LGBTQ, civil rights, and reproductive rights organization I know is ready to assist, both in advocating for our rights and in connecting us with resources.

As parents, we can ourselves assist our kids (of relevant age) process their feelings around the election and what they may be hearing from peers, the news, or online sources. We can listen to their concerns and remind them that when bullies win, the good people try harder; that change takes time, but we will always love and support them; and that we and they are part of a strong and vibrant LGBTQ community with a history of resilience and resistance. Those with children old enough can start (or continue) age-appropriate conversations about democracy, activism, social justice, and more, helping the next generation of citizens develop core values and be informed and engaged.

We can also get involved with LGBTQ and other social justice organizations (on an ongoing basis or for individual events), volunteer for political campaigns (mid-terms will be here before we know it), and continue speaking out for our families in our neighborhoods, school board meetings, and other local venues. And there are more personal ways to make a difference as well, reaching out to those in our communities who may need assistance in navigating today's uncertain currents. We shouldn't try to do everything—but it is incumbent upon us to do something.

It's okay to ask for help, too. At the very least, don't forget to take a break once in a while. Spend extra time in the park with your kids, or give them some extra screen time while you read a novel. If you don't have the luxury of spare time, do what you can to catch your breath—turn off the news and turn on some music while you commute or go to the grocery store, for example.

Remember, too, that there are sparks of hope. The election also saw many wins for LGBTQ candidates across the country. Notably, Sarah McBride (D-DE) was elected to the U.S. House, becoming the first out transgender person in Congress; Tammy Baldwin (D-WI), who was the

first out LGBTQ woman elected to Congress and then the first out LGBTQ person elected to the Senate, won reelection; and Sharice Davids (D-KS), who was one of the first two Native Americans and the first out LGBTQ Native American elected to Congress, was reelected to the U.S. House.

Looking just at LGBTQ parents, more than three dozen of us won election or reelection around the country, including Becca Balint (D-VT) and Angie Craig (D-MN), who were reelected to the U.S. House; Aime Wichtendahl (D), who will become the first out transgender person to serve in Iowa's state legislature; and Jack Patrick Lewis (D), who won reelection to the Massachusetts House. LGBTQ parents even won state legislative seats in several states that Trump won, and won city, county, judicial, and school board seats in several states.

Our community still has a voice. We have our families, we have each other, and we'll get through this together. Sending you love and strength for the days ahead.

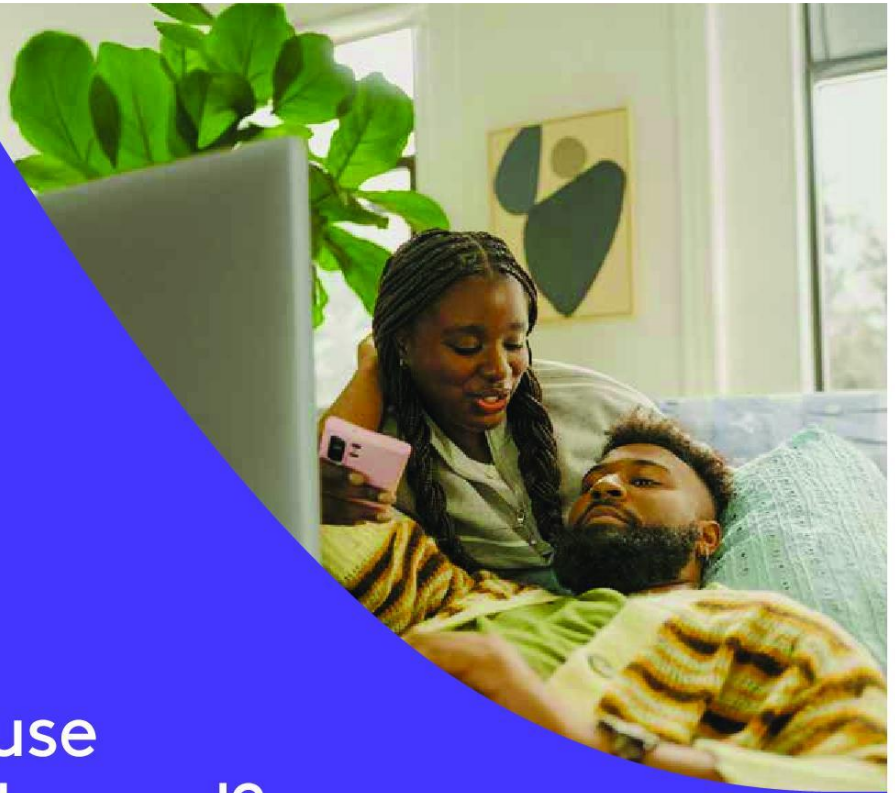
