Healey Proposes Her Own Social Media Bill

Advocates Remain Wary

Gov. Maura Healey unveiled her own youth social media legislation April 15, one week after the Massachusetts House passed what supporters called one of the country's

most restrictive youth social media measures, and as LGBTQ+ advocates warned both proposals could put queer young people at risk.

"This isn't a ban," Healey said at a State House news conference. "But it is deactivation." Her bill would require social media platforms to automatically disable features including infinite scrolling, autoplay video, push

notifications and algorithm-driven content feeds for users under 18. Users 16 and older could change those default settings themselves; users 15 and younger would require a parent or guardian to do so. The proposal also includes a two-hour daily limit for users under 16.

LGBTQ+ Immigrant Org Returns Grant After Death Threats, Media Firestorm

A Cambridge-based nonprofit that supports LGBTQ+ migrants has returned a \$7,500 Boston city grant and shut down a new wellness program after its founder received death threats and threats of being reported to Immigration and Customs Enforcement.

OU'Inewcomers, a community-led organization supporting LGBTQ+

asylum seekers, refugees and migrants in Greater Boston, launched its "Project Belonging Matters" program in mid-April, advertising small wellness vouchers to help low-income queer and transgender migrants access non-clinical supports including peer counseling, yoga, massage, hair styling, creative arts programming and other wellness services. The program required that all funds be spent within Boston city limits.

The program became a flashpoint

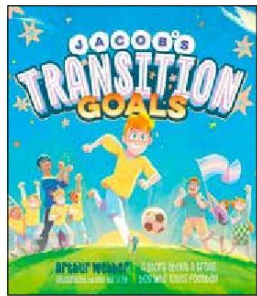
after Mass Daily News, a website operated by Mass Daily Media LLC, a Wyoming-registered limited liability company with no named publisher, editor or staff listed on its site, published a story highlighting the vouchers as taxpayer-funded benefits for immigrants receiving services such as "massages and hair salons." The story was later picked up by national outlets including the New York Post

3 New Picture Books Celebrate LGBTQ+ People in Sports

The WNBA's landmark 30th season is about to start; the newer PWHL (Professional Women's Hockey League), is heading into its third-season playoffs; and baseball, soccer, rugby, and other sports are in full swing. Three recent and upcoming picture books happily showcase sports as an integral part of many LGBTQ+ lives.

Why do these books matter? LGBTQ+ children and families often have difficult relationships

with sports, whether it's trans kids (particularly trans girls) wanting to play with others of their gender, queer girl athletes being told not to be too masculine, queer boy athletes being taunted for not being masculine enough, nonbinary kids seeking where they belong in the often binary world of sports, or LGBTQ+ parents and our children being ostracized on the field or in the stands. At the same time,

many LGBTQ+ people and our children have found community, strength, and belonging in sports—and these books may help more to do so.

“Jacob’s Transition Goals: A Story About a Trans Boy Who Loves Football,” by Arthur Webber, illustrated by Hui Qing Ang (Jessica Kingsley): Jacob dreams of playing for his local football team (as the U.K.-based author refers to soccer) and winning the league. He used to play for a girls’ team, he tells us, but after he came out as transgender, started playing with the boys.

Jacob then explains to readers what it means to be transgender (“when I was born, doctors said I was a girl, but I realized that I’m a boy”), and how his parents affirmed him and spoke with his coach to gain his support. While the coach was welcoming, though, some of the boys at his school were not. The coach intervened, telling the other boys that they must work together if they want to win. He also had a youth worker from a local LGBTQ+ group meet with them to explain more about being trans. (Importantly, the coach didn’t put that burden of explanation on Jacob.)

During the next match, the other boys included Jacob, who even scored a goal! The story closes with Jacob hoping to impress scouts from the local pro team—and a final image shows a grown-up Jacob triumphantly raising the league-winning trophy.

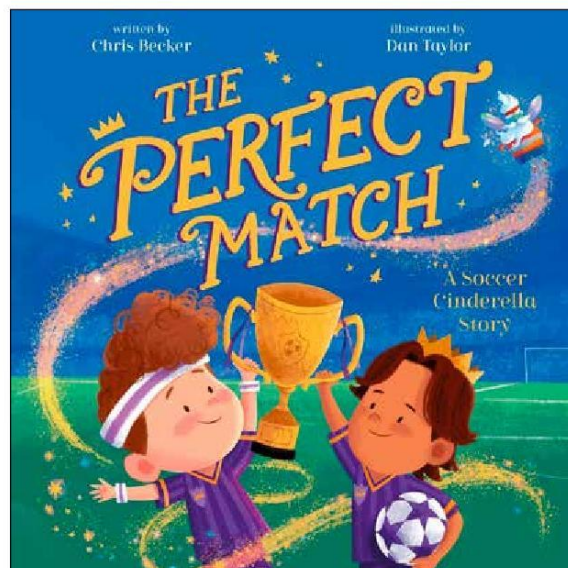
The story has a clear pedagogical purpose and takes a perhaps overly optimistic approach to the coach’s acceptance and the teammates’ rapid change of heart. It conveys the joy that can be had if trans youth are affirmed and supported, though, and that’s an invaluable message. The image of Jacob as a grown-up is powerful, too, showing young trans boys that they can have a bright future. This story isn’t just for trans boys, however; cisgender children with trans teammates may also learn important lessons—as may the adults in their lives.



“The Perfect Match,” by Chris Becker, illustrated by Dan Taylor (Nosy Crow): Jack loves when his dad tells him the bedtime story about Leo and the royal soccer match. In it, Leo’s mean brothers never let him play soccer, but instead make him do all the chores. When an invitation to the Royal Soccer Match arrives, Leo knows he won’t be able to attend—until the Hairy Squadfather arrives to magically transform him.

At the match, Leo scores the winning goal for Prince Ollie’s team—but exits the pitch before the magic wears off, leaving a silver cleat behind. Prince Ollie searches high and low for his team’s star, until he finds Leo, whose foot fits the cleat.

That’s Jack’s favorite part of the story—and his dads, King Leo and King Ollie, agree! Without that missing cleat, they never would have found each other and become a family. A final scene shows the three of them playing soccer outside their castle.



This isn’t the first queer picture book take on Cinderella (see “Cinderella and a Mouse Called Fred,” “Cinderelliott: A Scrumptious Fairytale,” and “Cinda Meets Ella: A Fairly Queer Tale,” among others), but it’s a fun new twist on the tale. It’s also notable that the villains are not the traditional step-relatives, but simply siblings. Not that bullying by anyone is good, but it’s best that step-relatives aren’t always the bad folks. It’s a recommended book and bound to be a story time winner.

“Play Proud: Fiercely Fabulous Queer Athletes,” by Rob Sanders, illustrated by Izzy Evans (Beaming Books): “Every athlete does their best... Out and proud, their lifelong quest,” begins this lively, rhyming ode to queer athletes. From well-known stars like Billie Jean King, Greg Louganis, and Megan Rapinoe, to ones that many readers will encounter here for the first time, like weightlifter Laurel Hubbard, NASCAR racer Zach Herrin, decathlete Tom Waddell, and more,

the athletes (and a few managers, coaches, and officials) cover a wide range of sports, eras, and identities.

The book is not, however, a collective biography per se. Each page simply offers a verse about a few connected athletes, such as: “Schuyler swam laps in the pool./Greg and Tom made splashing cool,” as bold, dynamic illustrations show them in action. For the picture book age range, this feels like a perfect approach to spark young readers’ interest, without overwhelming them with detail. (Backmatter includes additional information for those who want it.) The rhyme and meter keep the narrative moving like an athlete, creating a winning title that both tells us and shows us, “When you’re you, there’s no defeat.”

HRC targets battleground districts during broader reckoning over LGBTQ+ rights

WASHINGTON (AP) — The Human Rights Campaign, one of the nation's largest LGBTQ+ advocacy organizations, is vaulting into the midterms with a \$15 million investment targeting Republicans in battleground districts after a series of setbacks in recent years.

"I think that this is the election that's going to be the sea change, not only for getting to a pro-equality majority but for changing the momentum on this fight for equality," said Kelley Robinson, the Washington-based organization's president, in an interview with The Associated Press. "This movement is ready for its next wind, its second wind."

Besides eight congressional districts that could help determine control of the U.S. House, the Human Rights Campaign is also supporting Democratic candidates for the U.S. Senate in Georgia, Michigan, Minnesota, New Hampshire, Ohio and Texas. The money will be spent on

advertising, events and canvassers.

The LGBTQ+ movement has been reckoning with a wave of defeats on the campaign trail and in the courtroom that have left Democrats struggling to regain their footing.

President Donald Trump's Republican administration has rolled back protections for transgender people, such as banning them from serving in the military and cutting off gender-affirming care for children. The U.S. Supreme Court's conservative majority has upheld Republican states' restrictions while striking down bans on "conversion therapy" practices in Democratic states.

"I believe that our movement made ourselves believe that we were closer to equality than we actually are," Robinson said. "The last few years, we've been doing an incredible amount of listening, of learning, also of repositioning this work."

After the 2024 presidential election, Democrats were divided over the role that LGBTQ+ rights played in their party's losses. The Trump

campaign ran a series of advertisements mocking Vice President Kamala Harris for supporting medical gender transitions for incarcerated people and highlighting the issue of transgender people playing on women's sports teams.

"Kamala Harris is for they/them," said a voice-over in one national ad. "President Trump is for you."

Robinson argued that the ad was effective because of an implicit economic message, not for its critiques of the policy toward transgender people. But conservative activists and some moderate Democrats have argued such stances are too unpopular with swing voters.

"There's a real disconnect between most voters and the party elite," said Leor Sapir, a fellow with the Manhattan Institute, a conservative think tank.

He added, "If I'm a Democrat consultant, my advice would be: Do everything in your power to keep this issue off the public agenda."

Robinson said her organization has been soul-searching on how to best craft winning messages

on LGBTQ+ rights.

"Our job is to move away from the fireballs that our opposition wants to talk about and instead find a way to get back to the things that are impacting folks every day," she said.

In January, the Human Rights Campaign published a guide to blunting conservative attacks on LGBTQ+ issues, citing the successful campaigns of Virginia Gov. Abigail Spanberger and Kentucky Gov. Andy Beshear.

Although the guide encourages candidates to "lead with your values" and "address concerns directly," it also encourages them to "go big" and quickly pivot to issues like cost-of-living concerns.

"I think the number one way to shut out a voter is to try to make them believe that their fears are not real. So what we coach candidates on doing is listening," Robinson said. "For folks who have questions about the issues, that's OK. We're in a moment where the stakes in front of us are too high to look away."

We are all on Vance's humiliation tour

'Blessed are the peacemakers' was not said by Jane Fonda

Healey called her proposal "complementary" to the House bill, which passed 129-25 on April 8 and would prohibit children under 14 from opening social media accounts entirely, while requiring parental consent for users ages 14 and 15.

LGBTQ+ rights advocates, however, say both proposals could endanger vulnerable youth. Evan Greer, a Boston-based transgender activist and director of the digital rights group Fight for the Future, said the legislation overlooks research showing that social media can serve as a critical support system for queer young people.

"While numerous studies have shown that excessive social media use is harmful to youth mental health, other studies have shown that cutting LGBTQ youth off from social media actually leads to worse mental health outcomes," Greer said in a statement to Boston.com. "The data is quite nuanced, and while it supports action to crack down on predatory business practices, it does not support an outright ban."

Advocates also raised alarms about a parental surveillance provision in the House bill that would allow any parent — or anyone claiming to

be a parent — to request a minor child's social media account data, raising concerns about LGBTQ+ teenagers being outed to unsupportive families. The House LGBTQ+ Legislative Caucus offered an amendment narrowing that provision, limiting parental requests to age verification data only.

But in a statement issued April 23, Fight for the Future — joined by groups including the Massachusetts Transgender Political Coalition, the ACLU of Massachusetts, the Queer Neighborhood Council and the Transgender Emergency Fund — said the fix created a new concern: it requires companies to store sensitive age verification data, including government IDs or biometric face scans, in case a parent later requests it.

The groups also warned that facial analysis systems frequently fail for transgender people, and that an abusive or estranged parent could still have a queer teenager's account shut down using forged documents.

"The amendment offered by the LGBTQ+ Legislative Caucus, while well-intentioned, did not solve the core concerns with H. 5366, and will not protect LGBTQ youth from harm," the coalition said.

House lawmakers added language stating that

platforms may not disclose information related to a minor's sexual orientation, gender identity or other protected characteristics without consent. Education Committee Chair Rep. Ken Gordon, a chief backer of the House bill, cited that provision in a Boston Globe op-ed, saying LGBTQ+ concerns had been addressed. Advocates say it does not resolve the underlying risks.

A broad coalition of civil rights and privacy organizations has opposed mandatory age-verification requirements, warning they could expose users to data breaches and compromise anonymity for vulnerable communities. Similar laws in states including Florida and Ohio have faced significant First Amendment challenges in court.

"Massachusetts legislators are actively helping Trump's authoritarian takeover by pushing for legislation that expands censorship and surveillance," Fight for the Future said in its April 23 statement.

Because the Senate previously passed a narrower cellphone-focused measure and has not yet approved broader social media restrictions, lawmakers would need to reconcile major differences before any final legislation reaches Gov. Healey's desk.

The White House Correspondents Association dinner is always a great weekend for gays in DC to hook up with a politician or a political aide (or, in the worst possible case, a gay journalist). 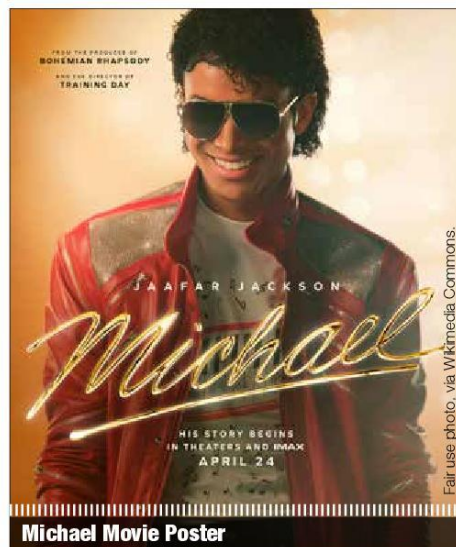

and Daily Mail.

OUNewcomers disputed that characterization, saying the reporting was misleading and took the program out of context. The organization said the initiative was intended as limited, need-based wellness support for vulnerable LGBTQ+ migrants — not unrestricted direct cash payments — and that no funds had been distributed.

"The severity of the threats we have received has made it impossible to continue this program safely,"

OUNewcomers founder **Sal Khan** said in a statement. "Our work has always been rooted in care, dignity, and community support."

A Boston city spokesperson confirmed to Boston.com that the funds will be returned and that no money had been distributed.

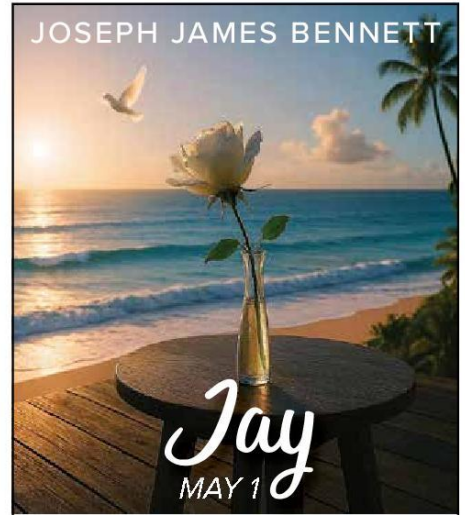
"No funds were distributed for this purpose. The organization is returning the funds to the City. The \$7,500 grant was awarded to support mental health programs and services — using it for the voucher program being referenced was never allowed and is not happening," the spokesperson said.

The city's own Weaving Well-Being

program page on Boston.gov describes the grant as funding "community-led mental health and well-being programming" and "non-clinical practices" for Boston immigrant residents.

OUNewcomers, founded by Khan in 2023, was one of 45 organizations selected through the Mayor's Office for Immigrant Advancement's Weaving Well-Being initiative. Khan said the organization will continue operating through private donations.

"This is something greater than myself," Khan told Boston.com. "I've been advocating for people like me since I've been here so that people understand our humanity."
